DOCUMENTS *attach in this order behind application: essay, nomination*

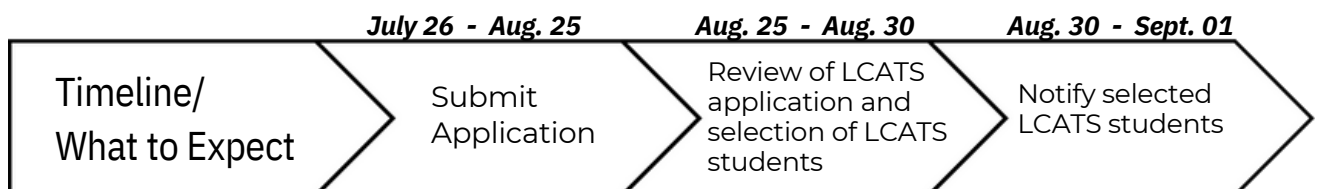
TRANSPORTATION
